Identify yourself as a Court Referral and state that you are calling about the Emergency Eviction Program. You will need the following documents when you meet with your case manager:

- 1. Proof of income for all family members in the household;
- 2. Social Security numbers of all family members in household;
- 3. Copy of court order, and/or five day Notice or Court Summons;
- 4. Signed statement from landlord verifying willingness to waive late fees (case manager will contact landlord if you furnish landlord's phone number);
- 5. Birth Certificates for children;
- 6. Picture Identification for applicant(s).
